Dear Madam or Sir,

The order of the 24th July 2015 has enforced the decision 2015-DC-0503 of the French Authority for Nuclear Safety (ASN), which establishes an obligation of registration for the companies performing the following transport operations:

- carriage of radioactive material packages;
- loading or unloading of these packages;
- handling of these packages, after loading or before unloading;

when they take place, at least partially, on the French territory. Companies performing transport by sea or air are concerned if the carriage includes a stop in a French port or airport.

Companies performing transport operations only for radioactive material for which they are already authorized or registered in France are not concerned.

The prescriptions of the French regulation concerning workers protection against radioactivity are now fully applicable to transport companies.

The companies have to register for their activity, but there is no need to register each transport operation individually. Registration is done on the ASN website: <http://professionnels.asn.fr/Transport-substances-radioactives/Declaration-des-entreprises-realissant-des-transports-de-substances-radioactives>. The first step is to create an account, then to log in and to follow the indications. A receipt of registration is automatically generated at the end of the process, when all mandatory fields have been filled. The website is only available in French, you can find attached to this letter a translation of the technical terms used.


From the 15th of October 2016, companies will have to be registered to perform transport operation in France.

No classified information should be sent to the ASN on the website.

Besides, during registration process, the companies are asked for the number of transport operations and of packages loaded, unloaded or handled. These numbers can be based on an estimation for the coming year or on the numbers from the last year. Likewise, the companies can enter the loading and unloading places and storage in transit areas they plan to use for the coming year. If they are not known, the ones used on the last year can be indicated instead.
